corporation with its principal office located at Akren, Ohio,
do hereby certify that a meeting of the holders of the shares
of The Firestone Tire & Rubber Company entitled to be voted
on the proposal before said meeting to amend the Amended
Articles of Incorporation of The Firestone Tire & Rubber
Company as contained in the following resolutions was duly
ealled for such purpose and held on September 21, 1971 at
which meeting a quorum was present in person or by proxy,
and that by the affirmative vote of the shareholders entitled
under the Amended Articles to exercise at least two-thirds of


