The Union Central Life Insurance Company ("Union Central") is an Ohio domiciled life and health insurance company that has applied to the Director of Insurance of the State of Nebraska ("Director") for approval to change its domicile from Ohio to Nebraska. After reviewing the filings, correspondence and all pertinent information provided to the Nebraska Department of Insurance, ("Department"), the Director hereby approves the application and finds, concludes and orders as follows:

FINDINGS OF FACT

- 1. On or about March 9, 2009, Union Central filed an application and a plan to redomesticate from Ohio to Nebraska pursuant to *Neb.Rev.Stat.* §44-161 through §44-164 (redomestication provisions) and the provisions of the Nebraska Business Corporation Act. Said application and plan was supplemented throughout the Department's review process.
- 2. Union Central is an Ohio domiciled life and health insurance company. Union Central first received a certificate of authority to transact the business of insurance in the State of Nebraska on January 1, 1870.
- 3. Union Central desires to change its domicile from Ohio to Nebraska and the Board of Directors of Union Central has determined that it is in the best interest of Union Central, its policyholders and its shareholder for Union Central to become a domestic company in the State of Nebraska. Union Central's sole shareholder, Ameritas Life Insurance Corp., and

UNIFI Mutual Holding Company, its ultimate controlling parent, have approved the redomestication. This was preceded by the Board of Directors of UNIFI Mutual Holding Company and the Board of Directors of Ameritas Holding Company ("AHC") causing AHC to contribute all of the issued and outstanding capital stock of Union Central to Ameritas Life Insurance Corp., resulting in Union Central becoming a wholly-owned subsidiary of Ameritas Life Insurance Corp., which repositioning was approved by the Ohio Department of Insurance by order dated April 15, 2009. In addition, Ameritas Life Insurance Corp. and AHL have financially committed to Union Central.

- 4. Union Central requested the redomestication be effective before April 30, 2009.
 The Ohio Department of Insurance approved the redomestication from Ohio to Nebraska by
 Order dated April 16, 2009.
- 5. The Board of Directors of Union Central has approved this transaction and this application and has caused Union Central to file Amended and Restated Articles of Incorporation and Bylaws for Union Central to effect the transfer of Union Central's domicile to Nebraska.
- 6. Union Central has submitted all documents, information and filings required by Nebraska law and the Department, including the application, plan, Restated Articles of Incorporation and Bylaws, and the statutory trust deposit.

CONCLUSIONS OF LAW

1. The State of Nebraska Department of Insurance has jurisdiction over the subject matter and the parties to this transaction pursuant to *Neb. Rev. Stat.* §44-101.01 and §44-161.

2. The approval of this application, Restated Articles of Incorporation and Bylaws will not, in any manner, impair the rights, remedies or security of any existing policyholders of either Union Central or Ameritas Life Insurance Corp.

3. The application, plan, Restated Articles of Incorporation and Bylaws comply with the applicable Nebraska laws and should be approved.

4. After the redomestication, Union Central will meet all requirements for holding a Certificate of Authority as a Nebraska domestic life and health insurer.

5. The application complies with all requirements and Nebraska insurance law and it should be approved.

ORDER

IT IS THEREFORE ORDERED that the application of The Union Central Life Insurance Company to transfer its domicile from Ohio to Nebraska is hereby approved.

The Nebraska Department of Insurance will issue The Union Central Life Insurance Company a certificate of authority to do the business of insurance as a domestic life and health insurer in the State of Nebraska.
