



Gentlemen:

I am in receipt of your corporation capital stock tax report with a check for \$1,000.00 to pay the maximum corporation capital stock tax for 1949 and I am enclosing a receipt accordingly.

I note from my records that when you qualified in Florida you paid a qualification tax on an allocation of \$821,000.00. It now appears that you have increased your allocation to \$2,000,000.00 and you are liable for an additional qualification tax on this amount which has no relation at all to the annual corporation capital stock tax. This is by reason of the fact that you allocated capital when you qualified rather than pay on your total authorized capital stock.

The additional cost will amount to \$341.50 and if you will send me another check for that amount I shall be glad to forward you receipt and a certificate showing your compliance with the law.
