

CERTIFICATE

REDUCTION OF CAPITAL

of

ST. REGIS PAPER COMPANY

Pursuant to Section 28 of the Stock Corporation Law

We, ROY K. FERGUSON and WILLARD J. DIXON, being respectively the President and Secretary of St. REGIS PAPER COMPANY (hercinafter sometimes called the "Corporation"), hereby certify:

- 1. The name of the Corporation is "St. Regis Paper Company."
- 2. The Certificate of Incorporation of the Corporation was filed in the office of the Secretary of State of the State of New York on February 4, 1899 and in the office of the Clerk of Jefferson County, State of New York, on February 6, 1899.
- 3. The Corporation has heretofore purchased or redeemed and has heretofore retired 16,000 shares of First Preferred Stock, 4.40% Series A (having a par value of \$100 per share) having an aggregate par value of \$1,600,000 and has applied capital to such purchase in the amount of \$1,600,000, the aggregate par value of such shares. The Certificate of Incorporation of the Corporation is hereby amended to eliminate such 16 000 shares of First Preferred Stock from the authorized capital stock of the Corporation and to reduce the capital of the Corporation by \$1,600,000, the aggregate par value of such shares of First Preferred Stock.
- 4. The provision added to the Corporation's Certificate of Incorporation by certificate filed pursuant to law setting forth the amount of the capital stock of the Corporation is hereby amended to read as follows:

"The amount of the capital stock which the Corporation may hereafter have is \$59,878,570, the capital stock of the Corporation being reduced to such amount by this certificate. The amount of capital of the Corporation is hereby reduced to \$43,253,570."

5. The provision added to the Corporation's Certificate of Incorporation by certificate filed pursuant to law setting forth the total number of shares which the Corporation may henceforth have is hereby amended to read as follows:

"The total number of shares, including those previously authorized, which the Corporation may henceforth have is 7.719,714 shares, of which 224,000 shares classified as First Preferred Stock shall be of the par value of \$100 each and 7,495,714 shares classified as Common Stock shall be of the par value of \$5 each. None of the shares which the Corporation may henceforth have shall be without par value."

6. The capital of the Corporation is hereby reduced from \$44,853,570 to \$43,253,570 by a charge against capital in the amount of \$1,600,000, the aggregate par value of, and the capital represented by, the above-mentioned 16,000 shares of the Corporation's First Preferred Stock, 4.40% Series A of the par value of \$100 per share, such shares being hereby eliminated from the enumeration and description of shares which the Corporation is authorized to issue.

The surplus, if any, resulting from such reduction of the amount of the capital shall be available to be used for any purpose for which surplus may be used.
