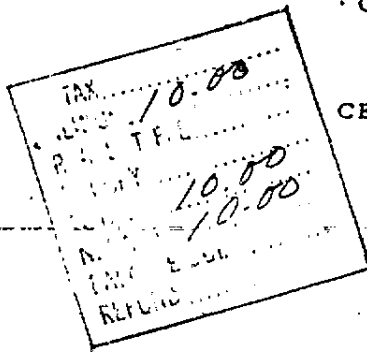

We, JOHN E. COWLES and HOMER CRAWFORD, being
respectively the Vice President and Treasurer and Secretary of ST. REGIS
PAPER COMPANY (hereinafter sometimes called the "Corporation"),
hereby certify:

1. The name of the Corporation is "St. Regis Paper Company".
2. The Certificate of Incorporation of the Corporation was
filed by the Department of State of the State of New York on February 4, 1899.
3. The Corporation has heretofore purchased or redeemed
and has heretofore retired 150,000 shares of First Preferred Stock, 4.40%
Series A (having a par value of \$100 per share) having an aggregate par value
of \$15,000,000 and has applied capital to such purchase in the amount of
\$15,000,000, the aggregate par value of such shares. The Certificate of
Incorporation of the Corporation is hereby amended to eliminate such 150,000
shares of First Preferred Stock, 4.40% Series A, from the authorized capital
stock of the Corporation.

4. The provision added to the Corporation's Certificate

of Incorporation by certificate filed pursuant to law setting forth the total number of shares which the Corporation may henceforth have is hereby amended to read as follows:

"The amount of the capital stock of the Corporation shall be one hundred and thirty million dollars (\$130,000,000) divided into ~~twenty-five million fifty thousand (25,050,000)~~ shares of which fifty thousand (50,000) shares, classified as First Preferred Stock, shall be of the par value of one hundred dollars (\$100) each and twenty-five million (25,000,000) shares, classified as Common Stock, shall be of the par value of five dollars (\$5) each. None of the shares of the Corporation shall be without par value.

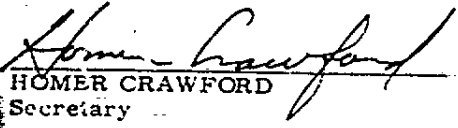
"The number of shares classified as First Preferred Stock is fifty thousand (50,000) and the number of shares classified as Common Stock is twenty-five million (25,000,000)."

5. The aforesaid amendments of the Certificate of

Incorporation of the Corporation were authorized at a meeting of the Board of Directors of the Corporation duly called and held on December 18, 1963, in accordance with Article IV(2)(c) of the Certificate of Incorporation of the Corporation.
