





.... CERTIFICATE OF AM . NOMENT CERTIFICATE OF INCORPORATION ST. REGIS PAPER COMPANY Under Section 605 of the Business Corporation 1 Pursuant to the provisions of Section 205 of the Business Corporation Law, the undersigned, William R. Adams, and Homer Crawford, being respectively the President and Secretary of St. Regis Paper Company (hereinefter sometimes referred to asthe "Corporation") hereby certify: Pirst. The name of the Corporation is St. Regis Paper Company. Second. The Certificate of Incorporation of the Corporation was filed by the Department of State of, the State of New York on February 4, 1899. Third. This Certificate of Amendment hereby amends the Certificate of Incorporation of the Corporation (i) to authorize the Corporation to issue a new class of Preferred Stock, to consist of one million shares of the par value of \$1 each, (ii) to authorize the Board of Directors of the Corporation to provide for the issue of the Preferred Stock and (iii) to eliminate Qualified in Ne ecretary of State

. Article VII of the Certificate of Incorporation providing for the number, qualification and election of Directors. To. accomplish such amendments

relating to the capital stock of the Corporation is hereby amended to read as follows:

> III. The aggregate number of shares which the Corporation shall have authority to issue is 26,000,000 of which . 1,000,000 shares shall be Preferred Stock, issuable in series of the par value of \$1 per share and 25,000,000 shares shall be Common Stock of the par value of \$5 per share.

2. There is hereby added to the Certificate of Incorporation new Article IV to read as follows:

> IV. Subject to limitations prescribed by . law, the Board of Directors is authorized to provide for the issue of shares of the Preferred Stock in one or more series, to establish the number of shares in each series, to fix the designation, relative rights, preferences and limitations of the shares of each such series and to cause to be filed in the Department of State of the
