We have received your correspondence dated 6/22/2000. In response, we are resubmitting copies of the original 2000 Uniform Business Reports for the following entities:

- Collins Radio Company (Reference Number: 830356),
- Rockwell Collins, Inc. (Reference Number: P98000001734), and
- Atomics International Inc. (Reference Number: 810560).

These returns were originally submitted with a cover letter requesting abatement of penalties. In mid-May we noticed that we did not have the Uniform Business Reports for these entities. Upon realizing this, we contacted the State and inquired if we could download the forms from an Internet site or if we could use the prior year return and modify it for the current year. The State representative informed us that we were required to use current year original forms. The representative stated that she would mail the forms; but that it may take five to ten business days for them to arrive. Based upon this information, we informed the representative that we might not be able to file the returns by May 31, 2000. The representative stated that when filing the returns we should attach a letter stating the facts and the penalties would be waived.

Upon receipt of the forms, we processed them immediately and attached a letter outlining the facts and requesting abatement of penalties. We believe we made a good faith effort to timely file these reports. Therefore, we respectfully request that all penalties be waived and the returns be accepted as originally filed.
