

# AMENDMENT TO THE ARTICLES OF INCORPORATION AND CERTIFICATE OF AUTHORITY

#### General remarks and official action taken:

On this day, the Commissioner of Insurance considered the application of SCOR LIFE U.S. RE INSURANCE COMPANY, Addison, Texas (the "Company"), for approval of an amendment to the Articles of Incorporation and for an amended Certificate of Authority changing its name and home office from SCOR LIFE U.S. RE INSURANCE COMPANY, Addison, Texas to SCOR GLOBAL LIFE U.S. RE INSURANCE COMPANY, Plano, Texas.

SCOR LIFE U.S. RE INSURANCE COMPANY has submitted documentation to staff of the Texas Department of Insurance indicating that it has amended its Articles of Incorporation to reflect the change in its name and home office. SCOR LIFE U.S. RE INSURANCE COMPANY has also submitted evidence to staff indicating that it has complied with the requirements set forth in TEX. INS. CODE ANN. §§801.051 – 801.053 and §841.156.
