THIRD: The Corporation hereby amends its Charter to effect a change in its corporate name as follows: Section 1 of the Charter, relating to the name of the Corporation, is hereby amended to read in its entirety as follows:

"Section 1. The name of the corporation shall be Royal & SunAlliance Personal Insurance Company."

FOURTH: The manner in which this amendment to the Charter was authorized was by unanimous written consent of the holders of all the outstanding shares entitled to vote thereon, subsequent to authorization by a majority vote of the board of directors.
