1. Article I shall be amended to read:

The name of the corporation shall be Guidant Mutual Insurance Company.

2. Article VII, Section 3, shall read:

At all annual meetings or special meetings of the members, the members present at said meeting, either in person or represented by proxy, shall constitute a quorum for the election of directors and for the transaction of any business that may be legally acted upon at such meeting; but in no event shall a quorum consist of less than the number of authorized directors, plus one.


