PLEASE TAKE NOTICE that on January 22, 2002, Kmart Corporation and 37 of its subsidiaries (collectively, the "Debtors") filed voluntary petitions under chapter 11 of the United States Bankruptcy Code. As of January 22, 2002, the automatic stay of 11 U.S.C. § 362(a) applies to bar any attempts to collect any debt that arose prior to such date.

Consequently, in accordance with the Bankruptcy Code, the Debtors have pro-rated the 2002 Uniform Business Reports. Specifically, the Debtors may only pay amounts that accrued after January 22, 2002 (i.e. 344/365 * \$150 or \$141.37) per corporation.
