

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF WISCONSIN MORTGAGE ASSURANCE CORPORATION

The undersigned authorized officers of Wisconsin Mortgage Assurance Corporation, a Wisconsin stock insurance corporation organized under Chapter 611 of the Wisconsin Statutes (the "Corporation"), hereby certify that, in accordance with all applicable provisions of Chapter 611 (and the incorporated provisions of the Wisconsin Business Corporation Law) as described below, Article I of such Corporation's Articles of Incorporation, as amended, was amended and restated in its entirety to read as follows:

First: The name of the corporation is MGIC Indemnity Corporation.

The undersigned authorized officers of the Corporation hereby certify as follows:

- 1. The foregoing amendment and restatement in its entirety of Article I of the Articles of Incorporation of the Corporation was duly adopted by the Corporation's Board of Directors on April 5, 2000, and by the Corporation's sole Shareholder on April 6, 2000, in accordance with Section 611.29 of the Wisconsin Statutes (and Section 180.1003 of the Wisconsin Business Corporation Law), and is to be effective at 12:01 a.m. on June 1, 2000.
