Ladies and Gentlemen:

Each year, Hartford Life receives the Florida Department of State Division of Corporations' 2001 Uniform Business Report for filing on behalf of Toyota Motor Life Insurance Company, the former name of Nutmeg Life Insurance Company. Your department has confirmed that the forms have been filed through 1999 (filed in 2000).

Last month, while preparing the 2000 form, I realized that not only had the Toyota-Nutmeg name change never been effected with the Division of Corporations, but the registered agent for service had never been changed either. While advising me of the procedures for filing these changes in Florida, the Corporations clerk mentioned that Toyota is no longer licensed to do business in that state. Toyota had surrendered its license there in the early 90's, several years prior to its being acquired by Hartford on December 31, 1999. She further explained that in order for Nutmeg to do business in Florida going forward, we would essentially start "from scratch" by applying for a license under that name. In short, no name change or agent change are necessary because we are not permitted to do business in Florida under the Toyota name.

Finally, in order to put an end to the annual filing forms' being unnecessarily issued under the Toyota name, the clerk said we should file an "Application by Foreign Corporation for Withdrawal of Authority to Transact Business or Conduct Affairs in Florida" (enclosed).
