Dear Mr. Blankenbaker,

Thank you for taking the time to review this company's registration with the Division and thank you for your offer to assist with the accurate updating of the status of National Distributing Company in your agency's records. The Division inaccurately shows National Distributing Company as having not filed an annual report or the \$150 fee.

As you recall from your conversation with our counsel in Tallahassee, Mr. Scott Ashley, you noted the likely cause of the inaccurate record for National Distributing Company resulted from mailing our completed annual report attached to another annual report for Bay Distributing, an affiliated company, with a single check in the amount of \$300. Our records and recollections confirm this. The entire amount was mistakenly applied only to the renewal of Bay Distributing, as your current records show.

Consequently, National Distributing Company's record in the Division's database incorrectly shows no filing or payment. Additionally, my designation as registered agent was only updated in the Bay Distributing record, leaving inaccurate the registered agent designation for National Distributing Company.

We are respectfully requesting that you update the Division's records to accurately reflect two \$150 fees, one paid to renew each company, and that I be designated as National Distributing Company's registered agent.

Please find enclosed a form for reinstatement with original signatures per your suggestion. Also, please find our file copies of the annual reports timely filed in January of 2005.
