# CERTIFICATE OF AMENDMENT OF CERTIFICATE OF INCORPORATION OF INITIATIVES OF CHANGE, INC.

Under Section 803 of the Not-For-Profit Corporation Law

We, the undersigned, Marshall M. Green and Steven Greisdorf, being respectively the Chairman of the Board and the Secretary of Initiatives of Change, Inc., do hereby certify:

- 1: The name of the corporation is Initiatives of Change, Inc. The name under which the corporation was formed was The Oxford Group-Moral Re-Armament, MRA, Inc.
- 2. The Certificate of Incorporation of said corporation was filed by the Department of State on the 13<sup>th</sup> day of March, 1941, and the law under which it was formed was The Membership Corporations Law of the State of New York.
- 3. The corporation is a corporation as defined in subparagraph (a)(5) of Section 102 of the Not-for-Profit Corporation Law and is a Type B corporation under Section 201 of said law. The Corporation shall continue to be a Type B corporation under Section 201 of said law after the within amendment is filed revising the corporate purposes.
- 4. The Certificate of Incorporation is hereby amended in the following respects:
  - (a) Article SECOND of said Certificate of Incorporation, which sets forth the purposes for which the corporation is formed, is hereby amended by deleting subparagraphs A and B in their entirety and substituting the following in lieu thereof:
    - "A. To advance the principles of the Oxford Group, founded in or about the year 1921 by Frank Nathan Daniel Buchman, and developed since about the year 1938 under the name of Moral Re-Armament.
    - "B. To disseminate educational material with respect to these principles among the people of the United States and other countries."

The balance of Article SECOND remains unmodified and in full force and effect; and

- (b) Article FOURTH of said Certificate of Incorporation, relating to the territory in which the operations of the corporation are principally to be conducted, is hereby climinated, so that the corporation's activities shall not be restricted to any principal state or territory.
- 5. The corporation having no members entitled to vote, the foregoing amendments were authorized by the Board of Directors of the corporation at a regularly acheduled meeting of the Board on December 4, 2004, duly held, by unanimous vote of the directors.
- 6. The Secretary of State is hereby designated as agent of the corporation upon whom process against the corporation may be served. The post office address to which the Secretary of State shall mail a copy of any process against the corporation served upon him is 1156 Fifteenth Street, N.W., Suite 910, Washington, D.C. et 20005.



#### RESTATED CERTIFICATE OF INCORPORATION

Under Section 805 of the Not-For-Profit Corporation Law

We, the undersigned, Marshall M. Green and Steven Greisdorf, being respectively the Chairman of the Board and the Secretary of Initiatives of Change, Inc., do hereby certify:

- The name of the corporation is initiatives of Change, Inc. The name under which the corporation was formed was.

  THE OXFORD GROUP MORAL RE-ARMAMENT, MRA, INC.
- 2. The Certificate of Incorporation of said corporation was filed by the Department of State on the 13<sup>th</sup> day of March, 1941, and the law under which it was formed was The Membership Corporations Law of the State of New York.
- 3. The Certificate of Incorporation of the corporation is amended to effect the following amendments as authorized by the Not-for-Profit Corporation Law:
  (a) to add a new Article SIXTH defining the corporation and specifying what type it is under said law and (b) to add a new Article SEVENTH designating the Secretary of State as agent for service of process against the corporation and specifying the post office address without the State to which the Secretary of State shall mail a copy of such process.
- 4. The text of the Certificate of Incorporation is hereby restated, as so amended, to read as hereinafter set forth in full:
  - "FIRST. The name of the corporation is Initiatives of Change, Inc.
  - "SECOND. The purpose or purposes for which it is formed are as follows:

    - B. To disseminate educational material with respect to these principles among the people of the United States and other countries.

- C. To engage in one or more activities of a religious, charitable or educational nature which may be necessary or proper to carry out said purposes or objects.
- D. The exercise of all or any of the following powers:
  - (1) For use in furtherance of the aforesaid purposes and objects to receive donations, subscriptions, contributions or bequests either in the form of money or other property.
  - (2) To establish and support, or aid in the establishment and support of, any religious, charitable or educational associations or institutions, and to contribute money for religious, charitable or educational purposes in any way connected with the purposes of the corporation or calculated to further its purposes.
  - (3) To do all such other things as are incidental or conducive to the attainment of the above objects or any of them.
  - (4) The property acquired by this corporation is irrevocably dedicated to religious or charitable purposes, and upon the liquidation, dissolution or abandonment of the owner, will not inure to the benefit of any private person, except a fund, foundation or corporation organized and operated for religious or charitable purposes.
- "THIRD. The operations and activities of the corporation shall not result in a profit to it or to any of its directors, employees, members or subscribers, except that any director, employee or subscriber may receive fair and reasonable compensation for services rendered to the corporation.

"FOURTH. Its office is to be located in the Borough of Manhattan, City, County and State of New York.

"FIFTH. The number of its directors shall be not less than five (5) nor more than twenty-four (24).

"SIXTH. The corporation is a corporation as defined in subparagraph (a)(5) of Section 102 of the Not-for-Profit Corporation Law and is a Type B corporation under Section 201 of said law.
