#### Article.II

The corporation was originally incorporated under the laws of the State of Missouri, but has elected to continue its existence through adoption of the State of Connecticut as its corporate domicile. The date of incorporation shall be deemed to be April 1, 1935, which was the date of its original incorporation.
