At a joint meeting of the sole Shareholder and the sole Director, a quorum found to be present, the following amendment was adopted and ratified, effective October 31, 1998:

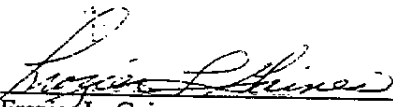
Pursuant to the provisions of §607.1006, Fla. Stats., this corporation adopts the following articles of amendment to its Articles of Incorporation:
