AMENDED ARTICLES OF INCORPORATION

FEDERAL KEMPER LIFE ASSURANCE COMPANY

<u>Article 1.</u> The name of the Corporation shall be CHASE INSURANCE LIFE AND ANNUITY COMPANY.

<u>Article 2</u>. The location of the principal office shall be Elgin, Kane County, State of Illinois.

Article 3. The duration of the Corporation shall be perpetual.

<u>Article 4</u>. The purpose for which the Corporation is formed is to engage in the following kinds of insurance and reinsurance business:

- (a) <u>Life</u>: Insurance on the lives of persons and every insurance appertaining thereto or connected therewith and granting, purchasing or disposing of annuities. Policies of life or endowment insurance or annuity contracts or contracts supplemental thereto which contain provisions for additional benefits in case of death by accidental means and provisions operating to safeguard such policies or contracts against lapse or to give a special surrender value, or special benefit, or an annuity, in the event, that the insured or annuitant shall become totally and permanently disabled as defined by the policy or contract, shall be deemed to be policies of life or endowment insurance or annuity contracts within the intent of this clause.
- (b) <u>Accident and Health</u>: Insurance against bodily injury, disablement or death by accident and against disablement resulting from sickness or old age and every insurance appertaining thereto.

<u>Article 5</u>. The corporate powers shall be exercised by a board of directors, not less than three nor more than twenty-one in number, elected by the shareholders of the corporation at the first special meeting held following this incorporation and thereafter to be elected by the shareholders of the corporation at the annual meeting. In all elections for directors each shareholder shall have the right to vote in person or by proxy the number of shares owned by him for as many persons as there are directors to be elected or to cumulate such shares and give one candidate as many votes as the number of directors multiplied by the number of shares of stock shall equal, or to distribute them on the same principle among as many candidates as he may desire. A director shall serve for a term of one year and until his successor is duly elected and qualified. The shareholders at any regular or special meeting may fill any vacancy in the board of directors for the unexpired term.

<u>Article 6</u>. The authorized capital shall be \$10,000,000 consisting of 500,000 common shares of the par value of \$20.00 per share, of which 136,351 common shares are issued and outstanding at the effective date of these Articles, as amended. The board of directors shall have the power, by appropriate resolution, to authorize the issuance or sale at any time or from time to time of the whole or any part of said 363,649 authorized but unissued common shares as additions to the paid up capital pursuant to one or more permits issued at any time or from time to time to time by the Director of Insurance of the State of Illinois.

<u>Article 7</u>. The board of directors shall adopt bylaws for its own government and for the government of the business of the corporation. The corporation may issue both participating and non-participating policies. The board of directors shall have power to determine the amount and manner of payment of dividends to the holders of participating policies. Such dividends shall be in accordance with such rates and rules and applicable to such kind or kinds of insurance as may be determined by the board of directors, which shall have power to adopt any bylaws or resolutions pertaining to such declaration and payment which in the judgment of the said board of directors seem necessary or desirable.

<u>Article 8</u>. <u>The fiscal year shall commence January first and terminate December thirty-first of each year.</u>
