## OF GE RESIDENTIAL MORTGAGE INSURANCE CORPORATION OF NORTH CAROLINA

GE RESIDENTIAL MORTGAGE INSURANCE CORPORATION OF NORTH CAROLINA (the "Company"), a North Carolina corporation, does hereby certify

FIRST: That the Board of Directors of the Company, by the unanimous written consent of its members, filed with the minutes of the board, adopted a resolution proposing and declaring advisable the following amendment to the Articles of Incorporation of the Company:

RESOLVED, that the Articles of Incorporation of GE RESIDENTIAL MORTGAGE INSURANCE CORPORATION OF NORTH CAROLINA be amended, effective as of November 1, 2005, by deleting the Article FIRST of the Articles of Incorporation and inserting the following new Article FIRST in lieu thereof:
