

The Corporation shall perpetual duration.

III

The Corporation is organized for the following purposes:

The objects and purposes of this corporation are to acquire and administer funds and property which, after the payment of necessary expenses, shall be devoted exclusively to religious, charitable, benevolent and eleemosynary purposes.

ΙÙ

The affairs of the corporation shall be managed by a board of directors (Board) consisting of not less than three (3) nor more than five (5) members. The method of election of directors shall be as determined by the By-laws of the corporation.

V

The corporation is not organized and shall not be operated for pecuniary gain or profit. No part of the property of the corporation and no part of its net earnings shall inure to the benefit of any director or other private individual.
