ARTICLES OF AMENDMENT TO THE CHARTER OF THE LAKE COMPANY

The undersigned professional cormonation hereby executes these Articles of Amendment for the purpose of amending its Charter:

- (1) The name of the corporation, until amended herein, is The Lake Company.
- (2) The following amendment to the Charter of the corporation was adopted by its shareholders on the 26th day of February, 1979, in the manner prescribed by law:

RESOLVED, that the name of the corporation be changed from "The Lake Company" to "Computer Credit, Incorporated."

- (3) The number of shares of the corporation outstanding at the time of such adoption was 4,450; and the number of shares entitled to vote thereon was 4,450. The corporation only has one class of shares, that being common shares.
