

AMENDMENT TO THE ARTICLES OF INCORPORATION

General remarks and official action taken:

On this day came on for consideration by the Commissioner of Insurance, the application of FIDELITY SOUTHERN INSURANCE COMPANY, Dallas, Texas, for approval of an amendment to the Articles of Incorporation changing its name from FIDELITY SOUTHERN INSURANCE COMPANY to FIDELITY FIRST INSURANCE COMPANY and for a Certificate of Authority evidencing such change. Since the amendment to the Articles of Incorporation involves only a change of name, a hearing is not required by law.

Action by FIDELITY SOUTHERN INSURANCE COMPANY as required and permitted by TEX. INS. CODE ANN. art. 1.14 and art. 2.03, has been evidenced to the Commissioner of Insurance. The amendment is properly supported by the required documents, which evidence that the name FIDELITY FIRST INSURANCE COMPANY, is not so similar of that of any other insurance company as to be likely to mislead the public.

Based upon the evidence submitted, it is hereby ORDERED by the Commissioner of Insurance, that such amendment be, and the same is hereby, approved. It is further ORDERED that a Certificate of Authority be issued to FIDELITY FIRST INSURANCE COMPANY, Dallas, Texas, evidencing the change effected by the amendment and that thereupon the prior Certificate of Authority No. 11374, dated December 16, 1996, be canceled.

ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

OF

FIDELITY SOUTHERN INSURANCE COMPANY

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, to the extent the same are not in conflict with the Texas Insurance Code, and the governing and applicable provisions of the Texas Insurance Code, and other laws and statutes of the State of Texas, the undersigned corporation, FIDELITY SOUTHERN INSURANCE COMPANY, a Texas corporation (the "Company"), hereby adopts the following Articles of Amendment to its Articles of Incorporation, as amended:

The name of the Company is FIDELITY SOUTHERN INSURANCE COMPANY.

The following Amendment of the Articles of Incorporation was recommended by the Board of Directors and adopted by the Sole Shareholder of the Company on December 9, 1996.

Article 1 of the Articles of Incorporation is amended to read as follows:

"Article 1. The name of the Company is FIDELITY FIRST INSURANCE COMPANY."

The number of shares of the Company outstanding and entitled to vote at the time of such adoption was 50,000.

The Sole Shareholder of all the issued and outstanding shares of the Company has signed a consent in writing adopting said amendments.
