It has come to our attention that the above-referenced Non-Profit Corporation is no longer recognized as an active corporation in Florida because the Uniform Business Reports were not filed in 2003 or 2004. Unfortunately, the post office box that was used as a mailing address for The Flagler Foundation, Inc. was closed in late 2002, causing the 2003 and the 2004 Florida Uniform Business Report forms to be returned to your office marked "undeliverable." I was advised by your office to enclose with this letter the Corporation Reinstatement Form and a Foundation check in the amount of \$122.50 (annual report fees for 2003 and 2004) and to request that the penalty of \$175.00 be waived.

We hereby respectfully request that you consider our situation and understand that the failure to file the Uniform Business Reports was not intentional but merely an oversight since the forms were never received.
