



ARTICLES OF AMENDMENT TO CERTIFICATE OF INCORPORATION OF DEGUSSA-HULS CORPORATION

Degussa-Hüls Corporation, an Alabama corporation, pursuant to the provisions of §10-2B-10.06, Code of Alabama, hereby certifies that the Certificate of Incorporation of Degussa Alabama, Inc., dated the 26th day of November, 1973, which was recorded in Real Property Book 1302, Pages 776-791, and as amended by Certificate of Amendment dated September 26, 1975, recorded in Real Property Book 1503, Pages 0004-0006, and as further amended by Certificate of Amendment dated February 24, 1976, recorded in Real Property Book 1627, Pages 0405-0407, and as further amended by Certificate of Amendment dated September 20, 1976, recorded in real Property Book 1640, Pages 0469-0471, and as further amended in the Articles and Plan of Merger of Degussa, Inc. into Degussa Alabama, Inc., dated September 30, 1977, as filed with the Secretary of State for the State of Alabama has been and hereby is further amended as follows:

FIRST: The name of the Corporation (hereinafter called the "Corporation") is:


