Ladies and Gentlemen:

Attached, please find the Application for Reinstatement of Lloyds Bank Plc. I learned during a telephone conversation with a representative from your Department last Wednesday, March 3rd, that your office had administratively dissolved Lloyds Bank's prior registration with your office due to our failure (i) to have filed a 1998 Renewal Application and (ii) to have paid our annual fee for 1998. I do apologize for this, but from what I was told over the telephone last Wednesday, I believe I know how this occurred.

As I told your representative over the telephone, we in Lloyds Bank's New York office did not receive registration renewal application papers from your office for 1998. I had believed that your renewal papers had (since 1997) been sent directly to Lloyds Bank's office in Miami (at which our Registered Agent is employed), and so I did not think it strange that these papers were not received at our office in New York. Your representative advised me over the phone, however, that the mailing address which you listed for Lloyds Bank until its administrative dissolution last October was "57 Fifth Avenue, New York, New York". The incorrect street number to which papers may have been mailed early in 1998 appears to be the reason that they were never received. The address listed in your records (57 Fifth Avenue) would actually be located several miles away from our actual office address (575 Fifth Avenue).

After I described the above to your representative over the telephone last Wednesday, he advised me to send a completed reinstatement application to you along with a check in the amount of \$300.00 (instead of the \$900.00 check which would normally be required) together with this letter of explanation for our failure to file (and pay our fee) in 1998. Accordingly, I am attaching a completed reinstatement application, our check in the amount of \$300.00, payable to your office, and this letter of explanation. We would be very grateful if you would waive the remainder of the reinstatement fee in
