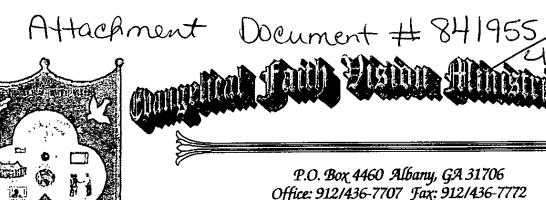

TO THE
ARTICLES OF INCORPORATION

The name of the corporation is Independent Holiness Deliverance Church, Inc.

Effective the date hereof, Article I of the Articles of Incorporation of Independent Holiness Deliverance Church, Inc., is amended to read as follows:

The name of the corporation is Evangelical Faith Vision Ministries, Inc. (hereinafter referred to as the "church"). The church is organized pursuant to the provisions of the Georgia Nonprofit Corporation Code.

All other provisions of the Articles of Incorporation shall remain in full force and effect.

This amendment was duly approved by the Board of Directors (also known as the Supreme Council) on March 1, 1995, in accordance with the provisions of Section 14-3-1002 of the Georgia Nonprofit Corporation Code. Section X of the Articles of Incorporation requires a four-fifths (4/5) vote of the directors to approve an amendment. All seven (7) present directors voted in favor of the amendment, thereby exceeding the four-fifths (4/5) vote necessary for adoption. No approval by members or any other person is required.
