ARTICLES OF INCORPORATION OF PLAZA INSURANCE COMPANY

(An Existing Missouri Corporation Redomesticating to Iowa)
PURSUANT TO THE PROVISIONS OF THE IOWA CODE
(Iowa Code §§ 515.78 and 490.902)

Plaza insurance Company, a corporation currently domiciled under the laws of 🕏 the State of Missouri, for the purpose of continuing its existence, without interruption, as a corporation organized under the laws of the State of Iowa, does hereby elect, pursuant to the laws of the State of Iowa, (Iowa Code §§ 515.78 and 490.902), to \$\exists\$ become redomesticated as an lowa corporation. Upon the taking of effect of these Articles of incorporation, Plaza Insurance Company shall be and continue to be possessed of all privileges, franchises, and powers to the same extent as if it had been, at all times during its corporate existence, incorporated under the laws of the State of lowa: and all privileges, franchises, and powers belonging to said corporation, and all property, real, personal and mixed, and all debts due on whatever account, all certificates of authority, agent appointments, outstanding insurance policies, capital structure, and all choses in action, shall be and the same are hereby ratified, approved, confirmed and assured to Plaza Insurance Company, with like effect and to all Intents and purposes as if it had been, at all times during its corporate existence, incorporated under the laws of the State of lowa. Without limitation of the foregoing, Plaza Insurance Company shall be given recognition as a domestic insurance company of the State of lowa for all purposes, from the date of its initial incorporation of July 20, 1972 in its original domiciliary state.

For the purpose of setting forth its Articles as an Iowa corporation, Plaza Insurance Company hereby adopts the following Articles of Incorporation.

- 1. Name. The name of the corporation shall be Plaza Insurance Company.
- 2. <u>Location</u>. The street address of the corporation's registered office and principle place of business shall be 1300 Woodland Avenue, West Des Moines, Polk County, Iowa 50265, and the name of the registered agent located at that address is Brian J. Blauw.
- 3. <u>Purpose</u>. The corporation is formed for the purpose of conducting the business of and acting as, an insurance company with the power to write such kinds of insurance and reinsurance as is comprised under Section 515.48 of the lowa Code, as now in force or hereafter amended. The corporation shall have the power to do all acts and things necessary, convenient or expedient to carry out the purposes for which it was formed.



- 4. Period of Duration. The period of duration of the corporation is perpetual.
- 5. <u>Corporate Powers</u>. The corporation shall assume all of the rights, powers and privileges now or hereafter granted to such corporate bodies, under and by virtue of the laws of the State of Iowa. The corporate powers shall be exercised by the duly constituted Board of Directors in accordance with the Articles and Bylaws of the corporation and the laws of the State of Iowa.
- 6. <u>Incorporator</u>. The incorporator of the corporation is Susan Bowron-White, 2955 North Meridian Street, Indianapolis, Indiana 46208.
- 7. <u>Board of Directors</u>. The Board of Directors of the corporation shall consist of the nine (9) persons named below who are presently serving as Directors of the corporation and who shall continue to serve as Directors of the corporation until the next annual meeting of shareholders of the corporation or until their successors are duly elected and qualified.

The nine (9) current Directors of the corporation are:

- 8. <u>Shares</u>. The maximum number of shares which the corporation is authorized to have outstanding is two million (2,000,000), all of which shall be shares of voting common stock, with a par value of \$2.25 per share.
- 9. <u>Limitation of Liability</u>. The private property of the stockholders, officers and directors of the corporation shall be exempt from and not be subject to the payment of corporate debt and liabilities to any extent whatsoever. This Article shall not be amended or repealed without the unanimous consent of the stockholders of the corporation in writing.

#### 10. Indemnification and Liability.

Section 1. The corporation shall indemnify, to the fullest extent not prohibited by lows law, any person made or threatened to be made a party to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative, by reason of the fact that he or she is or was a director, officer or employee of the corporation, or is or was serving at the request of the corporation as a director, trustee, officer, employee or member of any other corporation, or any partnership, joint venture, trust, committee or other enterprise or organization. The indemnification provided by this Article 9 shall not be deemed exclusive of any other rights to which any person seeking indemnification may be entitled under the Articles of Incorporation or Bylaws, or any agreement, vote of shareholders or disinterested Directors, or otherwise, both as to action in his or her official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director, trustee, officer, employee or member and shall inure to the benefit of the heirs and personal representatives of such a person.

Section 2. A director of this corporation shall not be personally liable to the corporation or its shareholders for monetary damages for breach of fiduciary duty as a director, except for liability for (i) the amount of a financial benefit received by a director to which the director is not entitled; (ii) an intentional infliction of harm on the corporation or the shareholders; (iii) a violation of lowa Code §490.833; or (iv) an intentional violation of criminal law.

#### FINAL ORDER FOR APPROVAL OF REDOMESTICATION

NOW, on this 177 day of Jawan 4, 2014, Director John M. Huff, after consideration and review of the request of Plaza Insurance Company (NAIC #30945) (hereinafter "Plaza") to redomesticate to the State of Iowa issues the following Findings and Orders pursuant to section 375.908 and 20 CSR 200-17.300.

#### **Findings**

- 1. On August 14, 2013, Plaza Insurance Company sent a request to the Missouri Department of Insurance, Financial Institutions and Professional Registration (hereinafter "Department") to redomesticate to the State of Iowa.
- 2. Based on the request for redomestication, Plaza is a Missouri domestic insurance company and has a certificate of authority to transact the business of insurance in Missouri.
- 3. On August 14, 2013. Plaza provided the Department with a copy of Plaza's Certificate of Authority to do business in the State of Iowa issued by the Iowa Department of Insurance on June 1, 2012.
- 4. On August 20, 2013, Plaza provided the Department with a copy of Plaza's Certificate of Authority to do business in the State of Iowa issued by the Iowa Department of Insurance on June 1, 2013.
- 5. Plaza has satisfied all conditions for redomestication contained in the Order for Contingent Approval of Redomestication dated September 27, 2013.
  - 6. The proposed transfer is not contrary to the interests of the policyholders of Plaza.
