The purpose of the mission agency of Mennonite Church USA is to lead, mobilize and resource Mennonite Church USA to participate in holistic witness to Jesus Christ, so that every congregation and all parts of the church will be fully engaged in God's mission, reaching from across the street to around the world, and for the aforesaid purposes to receive and hold all donations and bequests, and property, and funds from other sources, and manage, rent, lease, improve, sell or otherwise dispose of all real estate and personal property that may come into the possession of said institution from any source, and to manage, control, loan and invest for the aforesaid purposes of all funds of said institution.
