The foregoing amendment was adopted by the corporation's board of directors acting by unanimous written consent on May 22, 1997.

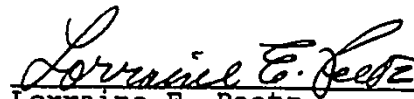
