

ENVIRONMENTAL DEFENSE, INCORPORATED Under Section 803 of the Not-for-Profit Corporation Law

It is hereby certified that:

FIRST: The name of the corporation is Environmental Defense, Incorporated (the "Corporation").

SECOND: The original Certificate of Incorporation of the Corporation was filed by the Department of State on October 19, 1967. The name under which the Corporation was formed is Environmental Defense Fund, Incorporated. A Certificate of Amendment was filed by the Department of State on January 26, 1977; a Restated Certificate of Incorporation was filed by the Department of State on February 4, 1985; and a Certificate of Amendment was filed by the Department of State on December 10, 1999.

THIRD: The Corporation was formed under the Not-for-Profit Corporation Law.

FOURTH: The Corporation is a corporation as defined in subparagraph (a)(5) of Section 102 of the Not-for-Profit Corporation Law. The Corporation is a Type B corporation under Section 201 of the Not-for-Profit Corporation Law.

FIFTH: The amendment of the Certificate of Incorporation of the Corporation effected by this Certificate of Amendment is to change the name of the Corporation.

SIXTH: To accomplish the foregoing amendment, Article FIRST of the Certificate of Incorporation of the Corporation, relating to the name of the Corporation, is hereby amended to read in its entirety as follows:

"FIRST: The name of the corporation is Environmental Defense Fund, Incorporated (the "Corporation")."

SEVENTH: The foregoing amendment of the Certificate of Incorporation of the Corporation was authorized at a meeting of the Board of Trustees (the "Board") at which a quorum was present, by the vote of at least a majority of the entire Board, the Corporation having no members entitled to vote on said amendment.
