### ARTICLES OF AMENDMENT (T.11A, § 10.06)

- 1. <u>Current Name of Corporation</u>. The current name of the corporation is Pizzagalli Construction Company. Pursuant to this amendment, the new name of the corporation shall be PC Construction Company.
- 2. <u>Text and Date of Each Amendment Adopted</u>. Article I of the corporation's Articles of Association is hereby amended to read as follows:

#### ARTICLE I NAME

The name of the corporation is PC Construction Company (hereinafter the "Corporation").

- 3. Exchange, Reclassification, or Cancellation of Issued Shares. Not applicable.
- 4. Shareholder Approval. The corporation hereby certifies that:
- (a) <u>Shareholder Approval Required</u>. The amendment required shareholder approval.
  - (b) <u>Voting on Amendments</u>.
- (i) <u>Votes Entitled to be Cast on Amendments</u>. The holders of 365,750 shares of the corporation's common stock were entitled to cast 365,750 votes (equal to one vote per share) on the proposal to amend Article I to change the name of the Corporation. All 365,750 shares of the Corporation's common stock are owned by a single shareholder, the Corporation's Employee Stock Ownership Plan (the "ESOP Trust"). At a meeting April 26, 2011, with all Trustees of the ESOP Trust present and participating, the Trustees considered and approved the amendment to Article I.
- (ii) <u>Votes Cast For and Against</u>. The total number of undisputed votes cast for the amendment to Article I was 365,750. The total number of votes cast against the amendment to Article I was zero. The number cast for the amendment was sufficient for approval.
- 5. Effective Date and Time. Pursuant to 11A V.S.A. § 1.24, this document and the amendment set forth herein shall be effective as of 12:01 a.m. on June 1, 2011.
