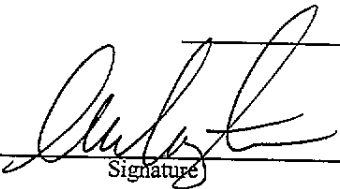

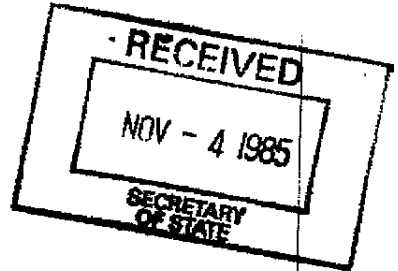

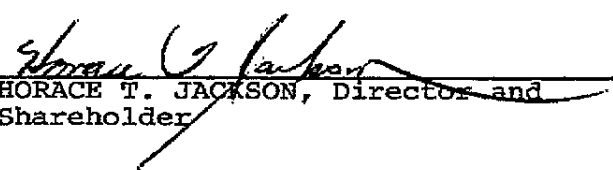
RESOLVED, that the name of the Corporation shall hereby be changed to "Tom P. Ollinger Construction, Inc."
