



Pursuant to Missouri law, Westport Insurance Corporation ("ERC" and the "Merger"), and ERC, as the surviving corporation (the "Surviving Entity"), hereby certifies as follows:

ARTICLE 1: <u>Constituent Corporations</u>. WIC is an insurance corporation duly organized and in good standing under the laws of the State of Missouri. ERC is an insurance corporation duly organized and in good standing under the laws of the State of Missouri.
