This letter is in reference to the administrative dissolution by the Department of State on November 1, 1985 of the above referenced corporation. Please note that I am a foreigner and do not live in this county. I was not aware of the yearly filing requirement until recently (this week) and want to activate the company's status with the state. In addition, the address on the annual form was incorrect and I never received any correspondence from the State charging the company the annual fee or notifying me of the dissolution for not submitting the payment. When I discovered the problem, we called the State and asked how to go about correcting this problem. I was told that a total of \$2,597.50 was the total in annual fees that would be due. We would also need to complete the reinstatement form, which I am including. I respectfully request that the Department waive the penalties for reinstatement because the late filing was due to reasonable cause and not willful neglect. I would have paid this annually had I known. I am including a check in the amount of \$2,597.50 for the original report fee for all of the years for which this has been outstanding. In addition, we have taken internal measures to assure that this does not happen again in the future.
