FIRST: That the Board of Directors of said corporation at an annual meeting on May 6, 1987, duly adopted a resolution proposing and declaring advisable the following amendment to the Certificate of Incorporation of said corporation:

RESOLVED, that the Certificate of Incorporation be amended by adding thereto a new Article TENTH, such Article TENTH to

"TENTH.
