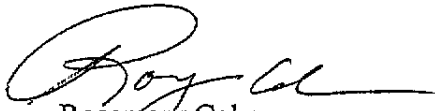

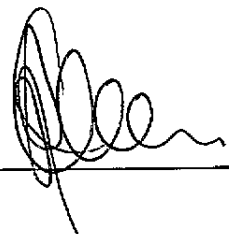

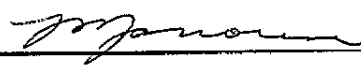
CORPORATE RESOLUTION

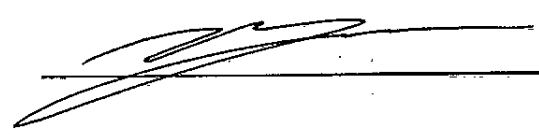
