The number of directors of this corporation shall be no less than three nor more than seven.

ARTICLE EIGHT is amended to read as follows:

ARTICLE EIGHT

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation, by distribution or other manner, to an organization or organizations as the Board of Directors shall determine, same being an organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes which qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law.
