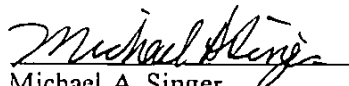
WHEREAS, it is in the best interest of the corporation to change its name to MEDICAL MANAGER RESEARCH & DEVELOPMENT, INC.
