1. The name of the Partnership is Normandy Partners of Jacksonville, Ltd. (hereinafter "Partnership").

2. The Certificate of Limited Partnership of the Partnership dated January 19, 2000 (hereinafter "Certificate") was filed with the State of Florida on January 21, 2000.

6. The latest date upon which the Partnership shall dissolve is  
June 30, 2040.

4. In all other respects, the original Certificate is hereby republished, ratified and confirmed.


The execution of this Certificate of Amendment by the undersigned general partner constitutes an affirmation under the penalties of perjury that the facts stated herein are true.
