
The enclosed documents are for the purpose of responding to your letter of December 28, 2000 and our conversation of today. It was not clear to me that each ammendment required the payment of new fees, or that the fee was based upon the amount named in each ammendment as to the "anticipated total contributions". You and your supervisor (whose name I did not get) informed me that if I would file this ammendment, stating the total anticipated amount of contributions at \$10,000,000 (which is my total eventual maximum amount), that this ammendment would be considered the one that should have been filed with the check I sent in December, and that I need only include the \$714, to bring the total fee to \$1,750, to make this ammendment effective.
