Then it should state the TOTAL AMOUNT CONTRIBUTED AND ANTICIPATED TO BE CONTRIBUTED BY THE LIMITED PARTNERS. This amount would also be \$49,000.00 from you indicate. (Please note that the \$1,000.00 being contributed by the GENERAL PARTNER is not to be included in either amount.)


