**AMENDED AND RESTATED
CERTIFICATE OF LIMITED PARTNERSHIP
OF
HORSESHOE DRIVE, LLLP**

The undersigned, Ridpath, Inc., being the sole general partner of Horseshoe Drive, LLLP (the "Partnership"), desiring to amend and restate in its entirety that certain Amended and Restated Certificate of Limited Partnership of Gordon Drive, LLLP, filed with the Florida Secretary of State on July 21, 2015, as amended, pursuant to Section 620.1202 of the Florida Revised Uniform Limited Partnership Act of 2005, hereby states the following:

- A. The name of the limited partnership is Horseshoe Drive, LLLP.
- B. The initial Certificate of Limited Partnership of Gordon Drive, LLLP was filed on April 7, 2000, and amended and restated on January 31, 2006 and on July 21, 2015 (wherein the name changed to Horseshoe Drive, LLLP).
- C. The Certificate of Limited Partnership of Horseshoe Drive, LLLP is hereby amended and restated as follows:
 1. The name of the limited partnership is Horseshoe Drive, LLLP (the "Partnership") and the Partnership is a Limited Liability Limited Partnership.
 2. The address of the office and the name and address of the agent for service of process on the Partnership is HL Statutory Agent, Inc., 5811 Pelican Bay Blvd., Suite 650, Naples, Florida 34108.
 3. The name and address of the sole General Partner of the Partnership is as follows:

 4. The mailing address of the Partnership is 2500 Horseshoe Drive South, Naples, Florida 34104.
 5. The Partnership shall have perpetual life and the passage of time shall not cause the dissolution of the Partnership.
