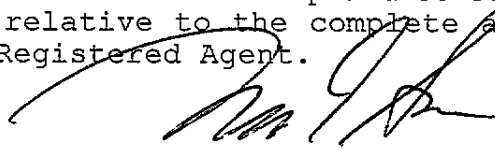

1. The amount of capital contributions to the Partnership to be made by the Limited Partners is Three Million Four Hundred Thousand Dollars (\$3,400,00.00).

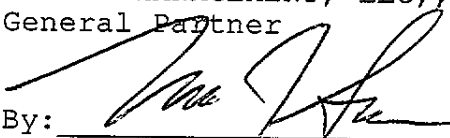
