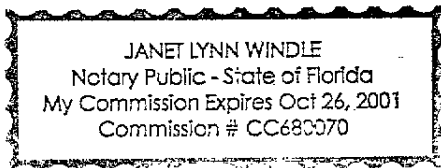

2. The limited partners have made capital contributions to the Partnership of assets with an estimated fair market value of approximately \$425,000.00. No future limited partner contributions are anticipated.

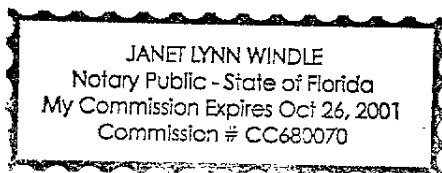

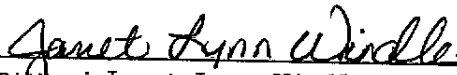
