Per our telephone conversation earlier, I am enclosing various communications and a brief history of what apparently transpired with the State of Florida.

Originally, we had estimated that the initial contribution to the FLIP was going to be \$1,800,000.00. It should have been filed by May 1, 2001. We were unable to file it by May 1 since we did not have a valuation at that time. When we finally did, the contribution was \$1,250,000.00. A check was submitted on 7-12-01 in the amount of \$526.25. That check was returned as we were told that \$926.25 should have been sent based on an additional \$400.00 for a late filing fee. Obviously, we could not file on time as we did not have valuations as of the filing date. On 8-3-01 a check in the amount of \$926.25 was sent. At that time a letter was received stating that the report was received without the check included. A call was made, and an apology given that the check must have been lost in their offices. A duplicate check on \$16.01 was sent. That check has never been cashed. No further correspondence was received by us until October 10, 2001. I am including all correspondence received to date. Please advise.
