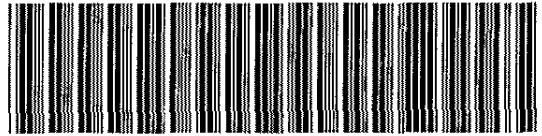

Pursuant to the provisions of Section 620.109, Florida Statutes, the above named Florida limited partnership (hereafter the "Partnership"), whose certificate was filed with the Florida Department of State on August 24, 2000, adopts the following certificate of amendment to its Certificate of Formation of Limited Partnership.

FIRST: Amera Associates, Inc., a Florida corporation, has been admitted to the Partnership as a new general partner.

SECOND: Tab Properties, Inc., a Florida corporation, has withdrawn as general partner.

THIRD: All partners have agreed in writing that the Partnership shall continue its business pursuant to the provisions of its Amended and Restated Agreement of Limited Partnership, notwithstanding the withdrawal of Tab Properties, Inc. as a general partner, and all partners have agreed in writing to the appointment of Amera Associates, Inc., as general partner.
