We are the accountants for the above referenced taxpayer who have asked us to correspond to your regarding the late fee assessed on the 2002 Uniform Business Report (UBR).


The taxpayer has concluded from their own investigation that either the original UBR was never received from the State of Florida or that the individual collecting the mail disposed of the notice along with junk mail received.
