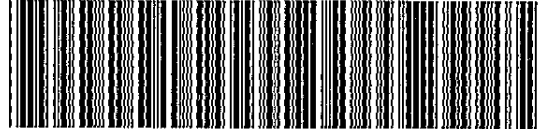

Article 1 of the Certificate of Limited Partnership is being amended to change the name of the Partnership to RWH DISPOSITION II, LTD.


