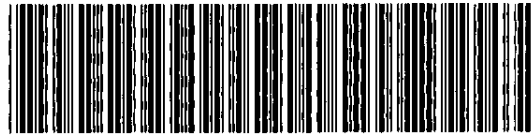

Pursuant to the provisions of Section 620.1202, Florida Statutes, and that certain Limited Partnership Agreement of Chandler Properties of Tallahassee, Ltd. dated October 18, 2000 (the "Limited Partnership Agreement"), this Florida Limited Partnership, whose certificate was filed with the Florida Department of State on October 25, 2000, adopts the following certificate of amendment to its certificate of limited partnership.

W I T N E S S E T H

THAT WHEREAS, there has previously been formed a limited partnership under the laws of the State of Florida known as Chandler Properties of Tallahassee, Ltd.; and

WHEREAS, GILBERT S. CHANDLER, JR. and BEULAH M. CHANDLER were initially designated as the General Partners thereof; and

WHEREAS, GILBERT S. CHANDLER, JR., resigned as a general partner of Chandler Properties of Tallahassee, Ltd. on July 1, 2008, and also resigned as the Registered Agent pursuant to Florida law and the provisions of the Limited Partnership Agreement. At the time of his death on April 28, 2010, Gilbert S. Chandler had no ownership interest in Chandler Properties of Tallahassee, Ltd.

NOW THEREFORE, in consideration of the hereinabove set forth premises and in consideration of other good and valuable considerations, the receipt and sufficiency of which is acknowledged, the certificate of limited partnership of Chandler Properties of Tallahassee, Ltd. is hereby amended as follows:

1. The name of the Registered Agent and Registered Office Address for Chandler Properties of Tallahassee, Ltd., which was previously filed with the Florida Secretary of State, shall be amended to reflect the following change previously made:
