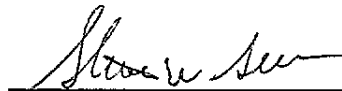

OF FIVE POINTS HEALTH CARE, LTD.

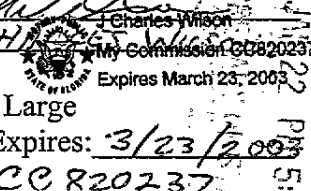
